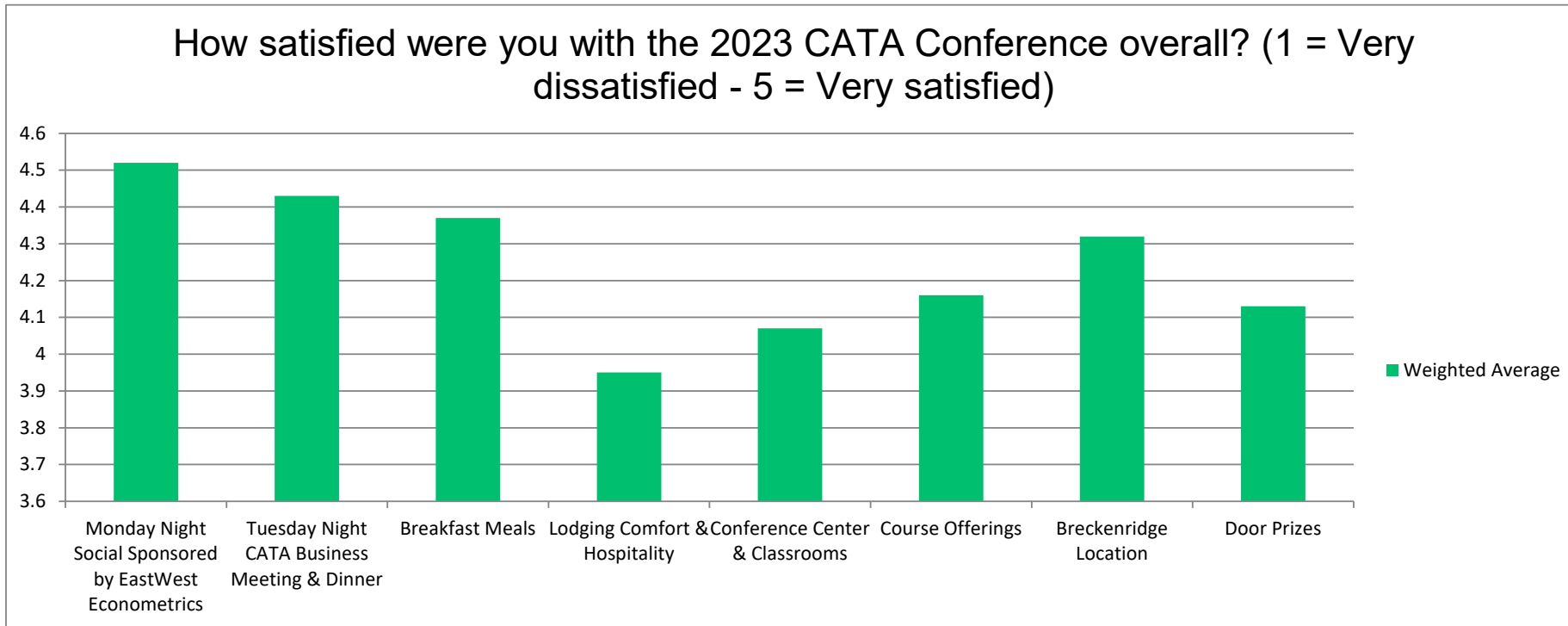

Wish commercial classes were spread out everyday, so I could attend all. No doubling on one day.

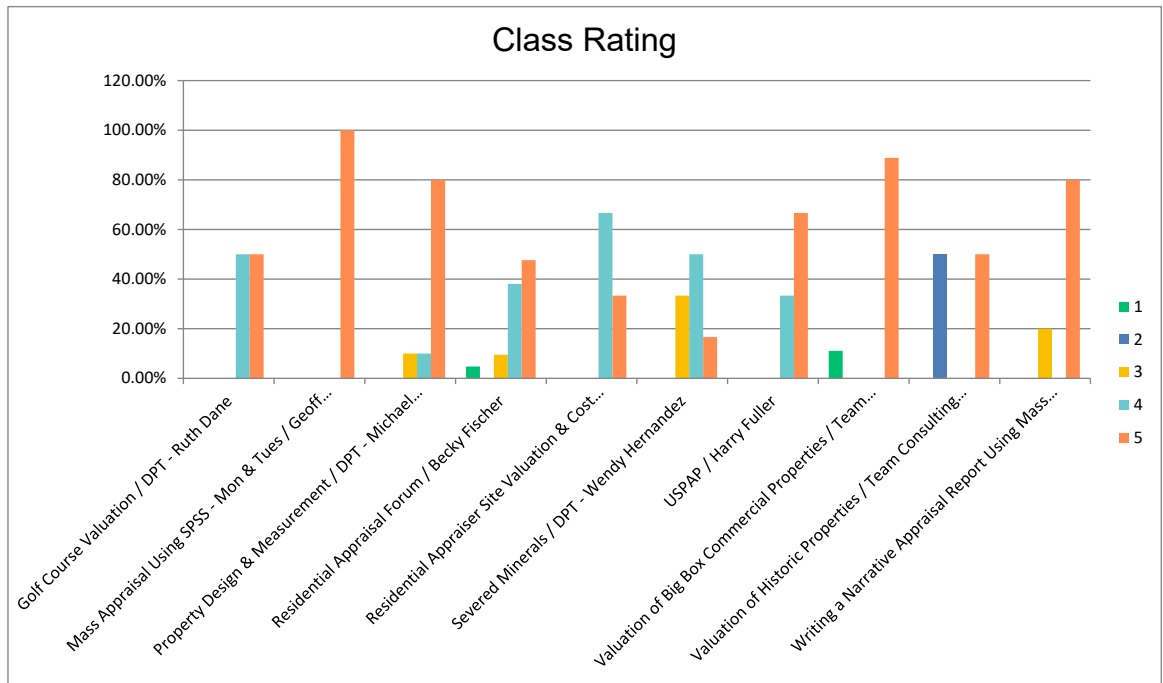
