The Division of Property Taxation (Division) is required to offer training by law according to Article X, Section 15 of the Colorado Constitution and 39-2-109 and 39-2-110 of the Colorado Revised Statutes. The statutes are very specific that this training should be offered to "assessors, their employees, and employees of the division"... The Division has an expanded interpretation of this limitation to include others that are working with the county assessor. According to this expanded interpretation, our classes are available to persons such as county commissioners, CBOE hearing officers, BAA hearing officers, county attorneys, vendors serving the assessor's office and contract employees of the assessor. If a prospective student's situation does not fit the description above there is an option to petition the Property Tax Administrator (PTA) for permission to attend the class. Traditionally, the PTA will look for some benefit to the county assessor's offices when granting an exemption.
