Cancellation Policy: For cancellations made more than seventy-two (72) hours of scheduled arrival, the member will be charged a processing fee of Thirty-Five Dollars (\$35) per reservation. For cancellations made within seventy-two (72) hours of scheduled arrival, the member will be charged for one night's lodging (room and tax). No-shows, early departures and/or late arrivals are non-refundable.

Tax Exempt Status – To receive tax-exempt status, the tax-exempt certificate and tax-exempt affidavit must be received 30 days prior to group arrival. Individuals responsible for their own accommodation will need to present a copy of their tax-exempt certificate upon arrival and pay with a company check or credit card.
